We are so excited that you will be joining us at Camp 5:5 this summer! The name Camp 5:5 comes from Revelation 5:5, "Then one of the elders said to me, "Do not weep! See, the Lion of the tribe of Judah, the Root of David, has triumphed". We are looking forward to ten great weeks of camps this summer! Please complete this form to reserve your camper's spot as space is limited! Spaces will be first come, first serve.

Each week has a specific theme that will be explored in various ways each day. There will also be trips to the pool.

**Structure of the Day:** Each camper's day will include:

- Start of day worship and Bible lesson
- Activities based around the weekly theme
- Field trips 2x/week, depending on age group (some of these outings may be a local park, zoo, laser tag, etc.)

Campers who are not currently registered at ECA or EKC will need to submit all enrollment forms, including a birth certificate and immunization record BEFORE their first day of camp. You will receive the needed paperwork after you complete this Registration Form. For campers currently registered at ECA or EKC, we will be in touch if additional forms or information are required.

We will be enrolling kids for the following class groupings, based on need:

Rising kindergarteners & 1st graders - Rookies  
Rising 2nd graders- Junior 1s  
Rising 3rd graders - Junior 2s

Rising 4th & 5th graders - Seniors  
Rising 6th - 8th graders - Middle School Mania

### **Pricing:**

\$25 registration fee per camper (turned in with this form).

The weekly fee is \$165 when you register by April 22. If you register after April 22, the weekly fee becomes \$180. Weekly fee is due upon reserving camper's spot, and will be paid prior to each week's attendance.

Local field trips (pool, parks, library) are included in each week's fee. Additional field trips (laser tag, zoo, etc.) will be included in that week's invoice.

**Before/After Care:** Before and After Care is an option for families that need it. It is \$2.50 for each 30-minute segment.

**Schedule:** I understand that I am reserving the following days for my camper. If a change must occur, a notice of two weeks must be given by email to Owen Donnelly (odonnely@eukaryaacademy.com). If a two week's notice is not received, I understand that I will be responsible for payment of days registered for. For last-minute schedule changes, I understand that I must receive confirmation that a spot is available before dropping off.

I understand that field trips and activities may expose my child to some risks and I assume any such risk that may arise there from. I accept full responsibility for all medical expenses for any injuries that might occur to my child by reason of his/her participation.

- (b) arising out of any damage or injury caused by my child; or,
- (c) arising out of a designated driver's operation of a motor vehicle in relation to these trips/activities.

I also agree to indemnify and hold harmless the released parties from any and all related costs, attorney fees, liabilities, settlements, and/or judgments.

## Medical Release

I authorize a designated representative of Eukarya Christian Academy to administer general first aid treatment for any minor injuries or illnesses experienced by child(ren) listed above. ## **Camp 5:5 2022 Parent Handbook**

Eukarya Family Center is a 501c(3) not for profit organization.

#### **1. Mission Statement**

- To provide a safe, nurturing environment where children feel accepted and loved
- To help each child develop a positive self-image and relationship skills by setting a Christian example of love and respect coupled with an introduction to God’s Holy Word
- To provide an environment where parents and staff work together to achieve the best possible care and education for the child
- To provide an opportunity for childcare providers to put their valuable skills to work, and to be recognized for their talents, dedication and the impact they have on each child’s life
- To provide a safe environment for parents to learn Biblical parenting values and put them to use.

#### **2. Statement of Faith**

The statement of faith adopted by Camp 5:5 is limited to those primary Christian doctrines central to all Christian denominations; which sets Christianity apart from other faiths. Portions of the following statement of faith are borrowed with permission from the National Christian Foundation for Education and the Arts By-Laws.

- We believe that the God of the Bible is the source of all truth. Thus, all genuine intellectual pursuits lead logically to God. This one God reveals Himself as three persons (Father, Son and Holy Spirit) and is self-existent, eternal, unchanging, omnipotent, omniscient, omnipresent, holy, righteous, and loving (2 Cor. 13:14; Col. 1:15-20).
- We believe in the verbal, plenary inspiration of the Bible. That is, it is the infallible Word of God, written by men ‘inspired’ by the Holy Spirit. As such, it, and not man, is the standard of truth (Jeremiah 9:23-24; Colossians 2:8; 2 Tim. 3:16-17). It is the ultimate source of knowledge about God and the only definitive guide for our daily lives.
- We believe the primary goal of life and education to be the glory of God which comes about by living a life that uses all our talents while pointing to Jesus Christ.
- We believe the gospel that, a) The only Son of God (Jesus) came in the flesh to take the sins of the world, was crucified, died, was buried and on the third day was raised from the dead (Romans 5:8; 1 Cor. 15:1-3), and that b) All who believe on His name are forgiven and granted eternal life (John 1:11-13, 5:24; Romans 4:5; Titus 3:5).
- We believe that every believer in Christ is inhabited by the Holy Spirit, and called through Him to “do greater works than (Jesus) did” (John 14:12). We believe that Christians need to learn to walk in the Spirit so they reflect the fruit thereof (Gal. 5:22-23).
- We agree with the Nicene Creed and the historic tenets ‘by Scripture alone’, ‘by the cross alone’, ‘by grace alone’, ‘by faith alone’, ‘Christ alone’, and ‘glory to God alone’.

- We seek to promote unity and charity among those who affirm these truths but have differing convictions within some areas of Christian life. We teach and apply dogmatically and unapologetically these truths, but acknowledge that sincere Christians hold differing views on certain non-essential issues.

### **3. Goals**

- To stimulate the cognitive, social, physical and emotional development of each child
- To promote in each child a positive self-concept, an acceptance of others and a sense of security
- To help each child learn to express themselves in many ways and be curious, imaginative and creative
- To help each learn to be responsible, want to learn and enjoy play
- To provide children with a basic introduction to the Bible
- To help children develop relationships and methods of communication based on respect, as well as, leading by example in a Christian environment
- To give parents opportunities to play an active role in their child's daily activities through active communication and volunteering
- To provide opportunities for staff to broaden their knowledge and experience of child development, helping them reach future goals
- To equip children with a concept of leading a Godly life, resulting in the ability to naturally demonstrate fruit of the spirit in daily interactions with others
- To encourage Biblical family structure and discipline
- Teach young people to worship a living God.

### **4. Non-discriminatory Policy**

Camp 5:5 admits students of any race, color, national or ethnic origin to all rights, privileges, programs, and activities generally accorded or made available to students at the school. It does not discriminate on the basis of race, color, national or ethnic origin in administration of its educational policies, admissions policies, or any other school- administered programs.

### **5. Admissions**

Camp 5:5 is open to children who are rising Kindergarten and older. The following forms are required for all non-ECA registered campers: Parents must complete a registration form, the parent agreement and the Medication Administration Acknowledgement form, Health Form (to be signed by a doctor), up-to-date Vaccination Record, Verification of Age (birth certificate, hospital record, etc.).

### **6. Hours of Operation**

Children who attend before care at EKC will be transported by bus to ECA campus, ECA will open at 7:30 a.m. All campuses will close at 6:00 p.m.

### **7. Drop off/Pick Up**

- Drop off occurs from 8:00am - 8:30 am. Children will be dropped off outside the library (upper) entrance of the building, where Mr. Owen or another staff member will greet them.
- Pick up occurs from 3:30pm - 3:45pm. Parents will drive around to the library entrance of the building, a staff member will be waiting to call students out to meet their families.
- All parents and students must enter the building through the library entrance.



## **8. Late Pick Up**

Please be mindful of when your child's camp day ends. If you think you may be late picking up your child, please call the ECA office at 540-868-0081 with as much notice as possible. In the case of a first time occurrence of less than 10 minutes AND with notice before pick up, we will waive the late fee. For all other occurrences, parents will be charged a late fee of \$25. After 15 minutes, a fee of \$1 per minute will be added until the child is picked up. After 3 or more late pick ups, the child's enrollment will be discontinued.

## **9. Holiday Closing**

Camp 5:5 will be closed on Monday July 4, 2022.

## **10. Brightwheel**

Brightwheel will be our primary camp information source throughout the summer. It is a program for your phone, tablet, or desktop that we will use to invoice, receive payments, check campers in and out, log activities for the day and communicate with parents. Upon registration, parents will receive an invitation to join Brightwheel through email. Once the account is set up, parents can find their check in code under "Settings". Parents may adjust their settings and how they receive information (text, email, push notifications). Parents are expected to keep the information on Brightwheel up to date. Staff will check campers in and out on Brightwheel each day. Parents are encouraged to communicate with teachers/staff through Brightwheel. Please be aware that our first priority is your camper, so the staff may wait until a break period to reply if the matter is not urgent.

\*Please note that Camp 5:5 administration does not have access to credit cards or bank accounts linked to Brightwheel.

## **11. Emergency Closings**

In case of an emergency, parents will be notified through Brightwheel, our camper information service. In the case that the center would need to close early, all children must be picked up within 1 hour of the initial notification. In the event of an emergency that would require children to relocate or evacuate the building, parents will be notified once it is safe for parents to pick up. In the interest of safety for the children, staff and parents, we ask that you do not come to pick up your child until we have instructed you to do so. We will only release children to people listed as authorized pick up.

## **12. Tuition and Fees**

Weekly payments are due by Wednesday of the week prior to your camper's attendance. Outing and field trip fees will be invoiced the week after the event takes place. If the fee is not received by Wednesday following the field trip, the child will be excluded from further activities off-campus. Payments can be made by check to the ECA office or through Brightwheel.

### 13. Other Payment Policies

- Camp 5:5 will only register children for camp if their fee is paid for on the Wednesday prior to your camper's attendance.
- There will be a fee of \$25 for any check returned.
- If your camper is absent, you are responsible for the corresponding tuition and fees.
- Completing the selection form is confirmation of fees to be incurred.
- If parents wish to adjust the camps that the child will be attending, we must receive written notice no less than 14 days before the change is to occur. Failure to do so will result in responsibility for the charges.

### 14. Cancellation of Camps

Camp 5:5 reserves the right to cancel camps that have less than 5 participants. A decision will be made no less than 7 days before camp is to run. Fees will be refunded for canceled camps.

### 15. Parent Roles

We are here to give your child a fun, exciting summer experience! To help us achieve this, we ask that you ensure your child has the following for each day of camp:

- sunscreen (we will keep this on-site during the duration of Camp 5:5)
- lunch packed in an insulated lunch box with an ice pack
- a sport cup labeled with the child's name
- one full change of clothes

Please notify the ECA office or the camp staff through Brightwheel or by calling the ECA office if your child is ill or will be absent.

### 16. Appropriate Dress

Children should be dressed appropriately for outdoor activities. Clothing should be practical; only closed toed shoes should be worn to Camp 5:5. **Tennis shoes are ideal! For safety reasons, children may not wear flip flops**, the exception being pool days. For water play, children can wear sandals with a heel strap. We will be spending a lot of time outside! If children do not have the appropriate clothing (i.e.: swimsuit and towel on pool days), they may be excluded from activities.

### 17. Meals and Snacks

Lunch must be provided from home. Lunchboxes must be marked with the child's name. For food that needs to be kept cold, please provide an insulated lunchbox with an ice pack. We will provide a morning snack at morning camps and an afternoon snack at after care. Special snacks may be brought in by families to celebrate birthdays and other special occasions. In the case of special dietary needs or health concerns (including food allergies), all food, including daily snacks must be provided by the family.

## 18. Electronics

Camp 5:5 is a screen free zone! We are unable to monitor all children's activity on electronic devices therefore for the safety of the children, we will not allow electronic devices while in our care. The only exception will be movies (no more than 1 per week), for educational and/or worship purposes. Please do not allow your child to bring cell phones, iPads, gaming systems, etc. We will not allow them to use them while in our care and they will be kept by staff until pick up. This also applies to before/after care.

If you feel your child must have a cell phone while at camp, it must be checked in with ECA staff. We have secure cell phone lockers available.

## 19. Safety Procedures

At ECA and EKC, the safety of those attending our center is top priority. The following guidelines have been set up to protect our families during periods of arrival and departure, please follow them closely.

- Parents must accompany the child into the building. *No child shall be dropped off to enter the building alone.*
- Children must be signed in and out daily with ECA staff.
- If someone is to pick up a child that the staff does not know, we will require ID and check the authorized pick up list. Parents may add folks as authorized pick up by updating the office. ID will still be required. If someone out of the ordinary will be picking up, please let camp staff or the office know.
- Parents and staff are encouraged to watch for traffic and drive slowly in the parking areas and driveway of the center keeping a close watch for children moving around the building. Please follow all directional arrows when following traffic patterns during drop-off and pick-up.

## 20. Transportation Policy

All children under 8 must have a carseat regardless of their size. Because of this, Camp 5:5 is providing car seats for children under 8, or for children who are older than 8 but under 80 pounds.

## 21. Health Policy

For the health and safety of all of our children, we are very strict about our illness policies. If your child becomes ill while at the center, you will be notified and expected to pick up your child within 1 hour of notification. Expect your child to be sent home for the following symptoms:

- Fever exceeding 99.9F
- 2 or more loose stools
- Vomiting
- Discharge from eyes, nose, throat, or ears
- Excessive coughing
- Any contagious illness
- Unidentified skin irritations
- Any indication of head lice

**Children must be symptom and fever free for 24 hours (without fever reducing medications) before returning to the camp or with a doctor's note indicating that the child may return to camp.**

## 22. Medications

According to state regulations, medications are to be administered by a staff member trained and certified in Medication Administration. This includes all topical (excluding sunscreen) and ingested medications, both prescription and over the counter. If for some reason there is not a certified staff member available on the day (or at the time) that a medication is to be administered, a parent will need to come to the camp and administer medications themselves. **We ask that *whenever possible* medications be administered at home and that the camp be asked to administer meds only when absolutely necessary.** When it is necessary to administer medication during camp hours, please bring the medication to the ECA office or with an ECA staff member so that we can ensure the forms are completed properly. All medication must be in the original packaging, with directions, and within the expiration date.

## 23. Sunscreen

All children will be required to wear sunscreen while outside between the hours of 9 am and 4 pm. Parents must provide a LABELED bottle of sunscreen to be kept at camp.

## 24. Media Policy

We like to take pictures of the children throughout the day. We enjoy sharing these pictures and videos on our social media. We also use these photos for advertisement, posting in the classroom for decoration, crafts projects, and special events. Our staff will never post your child's picture on their personal social media accounts. We will also never post your child's name with their picture with the exception of in the classroom or for art projects. If you would prefer that we not take pictures of your child, please indicate that using the Parental Agreement.
